WHAT WE DO

The Greater Paterson Opportunities Industrialization Center (**GPOIC**) provide help, assistance and Counseling for **WFNJ/TANF** customers that are either in danger of losing their Driver License or have had the Driving Privileges Suspended for the following notable reasons:

- Failure to appear in court or to pay fines i.e., tickets
- Failure to pay Motor Vehicle Surcharges
- Driving While Suspended
- Traffic Violations
- Failure to respond to a MVC notice

Our Story

Since the existence of The Greater Paterson OIC Strive To Drive (**STD**) program, where we assist/help our customers prepare for Motor Vehicles permit examination, also obtain their driver license. We've experienced on numerous occasions a strong need for assistance/help with payment of municipal violations/fines, restoration and/or surcharge fees of our WFNJ/TANF customers. The License Restoration Program was implemented to eliminate these barriers for the customer.

OUR SUCCESS STORIES

Since the existence of the License Restoration Program (LRP) we've provided support for numerous of **Workfirst TANF** (Temporary Assistance for Needy Families) customers, which have transitioned back into the Workforce. These customers varied from **CDL** (*Commercial Driver License*) holders to **CNA's** (*Certified Nurses Assistance*) and so on. We believe in "Helping a person, Help themselves" to gain stability in making their self-marketable in the Workforce.

- MVC Notice of Suspension (**Motor Vehicle Commission**)
- MVC Surcharge Letter (LDC)
- MVC Fee Payment Authorization Form (**Pink form**)
